Expanded pantry in warehouse & Paint/flooring for office.

Total Value \$17,000 100% Donated Builder Captains: KB Home/Richmond American

Impact: assisted in meeting 10X growth in need, able to qualify for larger grants, cold storage donations from Second Harvest.

The Lifeboat Project

Remodeled 4-unit condo building into 14 bed emergency shelter for survivors

Total Project Value: \$174,000 100% Donated Builder Captain: Park Square Homes

Completed Sept 2020

Freedom Ride

Rebuilt 1930's farmhouse into administrative offices for equine therapy helping homeless veterans and others



Quicker access to care

The right care at the right time



Better quality of care

Free preventative services--detect illness early


Greater choice of doctors/specialists

Reduce financial stress and avoid personal bankruptcy

Medical bills are the #1 cause of bankruptcy in the U.S.

AFFORDABLE CARE ACT--KEY CHANGES TO HEALTH COVERAGE

Made health insurance more affordable by offering a Marketplace with financial help where people could shop for coverage (healthcare.gov)



Required insurance companies to offer comprehensive benefits

Eliminated consideration of pre-existing health conditions as a reason to deny coverage

THE AMERICAN RESCUE PLAN ACT: The most significant change to healthcare access since the Affordable Care Act

Help for the Unemployed

Anyone receiving unemployment benefits in 2021 will qualify for \$0 premium plan

- Help for others who are low/moderate income
 Anyone earning less than 150% of the federal poverty level will qualify for a \$0 premium plan.
- Help for high income Individuals/Families

No one will be expected to pay more than 8.5% of their income on coverage

QUALIFYING FOR COVERAGE AND FINANCIAL HELP

To qualify for coverage, a client must

Have residence in Florida (homeless shelter address is ok)

Have a lawfully present immigration status

Not be incarcerated

To get financial help, a client generally must*

Have some income over 100% of the federal poverty level

Agree to complete a tax return each year

Not have an affordable offer of coverage from an employer

*immigrants residing in the US less than 5 years may qualify for financial assistance even if their income is lower

2021 only, have been or currently are collecting Unemployment benefits

FEDERAL POVERTY LIMITS--2022 COVERAGE

1 Person: \$12,880

2 people: \$17,420 married couple or single person with dependent

3 people: \$21,960 married couple with a child or single parent with 2 dependents

4 people: \$26,500 married couple with 2 dependents or single parent with 3 dependents

5 people: \$31,040
Married couple with 3 dependents or single parent with 4 dependents

WHAT COUNTS AS INCOME?

Count as Income

- Gross wages
- Spouse's income (if applicable)
- Self-employment income
- Unemployment benefits
- Rental income
- Investment/capital gains
- Social security and SSDI
- Taxable scholarships
- Alimony (if divorced before Jan 1, 2019)


Do Not Count as Income

- Veterans' benefits
- TANF payments
- Child support payments
- Sickness and injury payments
- Supplemental Security Income (SSI)
- Workers' compensation



Medicaid Gap

According to the Kaiser Family Foundation and Florida Voices for Health there are at least 400,000 people in Florida in the Medicaid Gap. Adults 18-65 who are homeless may fall into this category.



FREE HELP FROM A CERTIFIED NAVIGATOR

Encourage clients to apply for coverage with the help of a navigator

If a client is in the Medicaid Gap, a navigator will follow up with the client periodically to see if their situation has changed and work hard to get coverage

Some family members may qualify for Medicaid or Kidcare

Navigator has access to referral resources


