



The temporary shelter plan may be gaining traction...

On June 18, the Apopka City Council approved an agreement that would allow Matthew's Hope to park a special sleeper bus at a series of rotating locations in the city, providing at least 20 overnight shelter beds. It must locate funding and more parking places — the council approved just one of four proposed spots.

Modeled after the "407 Connect" project enacted in March by the city of Orlando, which is contracting with the Christian Service Center to operate two charter buses. The buses have been refurbished to offer sleeping compartments.

But there are some obstacles to the Apopka plan: Matthew's Hope still has to find funding for the bus and more places to park it. Apopka has only approved four locations to date.

Other temporary shelter plans using specialized trailers are in the preliminary planning stages for East Orange County and elsewhere. But they have yet to be approved.

2026 Florida Legislature (already!)

- > The Legislature is projecting a budget deficit for the 2026-2027 fiscal year of at least \$3 billion, and as much as \$7 billion.
- > Florida does have a rainy-day fund, though it is unlikely lawmakers will be willing to dip into that.
- > FCEH legislative advisors say any increases will be very difficult ... and we may face cuts.
- Watch for emails in the coming months to attend local delegate meetings; ask them to protect current budget levels.
- > DCF was supportive of trying to tweak the formula for TANF dollars, allowing more to go toward families experiencing homelessness. Currently, it is less than 1 percent.
- > More to come... The regular legislative session starts January 13, 2026. (Yes, sooner than you think!)

Help on the job front

Orange County Commissioners have approved a \$750,000 workforce partnership with First Step Staffing, expanding employment opportunities for veterans, individuals experiencing homelessness, and those with prior incarceration.

Employment opportunities cover a range of fields in county departments (facilities management, food service, landscaping, distribution, customer service, etc.). The partnership with First Step Staffing, Inc., will be facilitated through the county's Mental Health and Homelessness Division.


City of Orlando

- 100% clean energy by 2050 need everyone to get there.
- Many residents struggle with their electric bills (energy burdens at 130% of the national average).
- Some lack adequate air conditioning and have electric resistance heat and water heating.



City of Orlando

- Nearly 20% lack quality internet access in their home.
- Not everyone can afford a generator, or to stock-up on food before a hurricane. Losing the food in their refrigerator is catastrophic.



City of Orlando

- 62.3% of homes are rentals.
- Typically, the landlord owns everything while the tenant pays the electric bills difficult to justify energy investments.
- Most energy efficiency and resilience opportunities are geared towards homeowners.
- Low-income renters are afraid of being further left behind and don't always trust government programs.
- High potential for unintended consequences to improve a rental property (i.e. cause a rent increase and further exacerbate the affordable housing crisis).
- Energy efficiency and resilience could use better communication and more fun in outreach efforts

Our Role

- Fill the gaps find new ways to make energy efficiency, clean energy, and resilience accessible for all residents.
- If we can solve this for renters, homeowners will be easier.
- If we can bypass landlords, it will only be easier if the landlord wants to partner.
- May not be able to fix the whole home but can we help enough?



Energy Equity

Energy Equity

- Developed a new program, focused on <u>plug-in</u> technologies
 - Energy Star Window AC Heat Pump
 - Heat Pump Water Heater
 - 400W Portable Solar and Battery Storage
- Created energy efficiency baskets that feel more like a housewarming gift
 - Aerators with LED lights
 - Color changing LED bulbs
 - Glow stars
 - Threads for Teds
 - Educational Flyers
- The tenant can own all this stuff, similar to their own refrigerator or TV - bypassing the landlord.





Pilot Projects

Phase 1

- Provided in 4 homes via City funding
- We are building relationships and project success

Phase 2

- 4Roots donated 50 additional window AC units!
- Installed via City funding






Clear Lake Project Results

	Electric Consumption History (kWh)												
Year	Jan	Feb	Mar	Apr	May	Jun	Jul	Aug	Sep	Oct	Nov	Dec	AVG
2024	423	406	385	605	672	754	834	783	845	538	589	303	595
2023	661	522	567	744	1,058	1,117	1,407	1,519	1,109	798	732	530	897

- Energy savings over 30% for the year due to Energy Star Window AC
- Saving the resident nearly \$40 per month (closer to \$90 in the summer)
- Recently added portable solar and bumped the energy savings over 40%
- Added resilience Has back-up power for AC, refrigerator, etc.

Clear Lake Icing on the Cake

- At first, the resident did not realize solar power even existed. Now he is testing different devices on his solar system.
- Resident "I feel like I'm connected to the future."
- He just had us over for breakfast





Jernigan Ave Project Results

- We did not fix everything, but...
- Heat pump AC has reduced her winter bill by more than 30%
- Saving over \$30 per month
- She taught us... we created this program together!!!




